How to Submit Your Claims

ONLINE & MOBILE

- Login to greenshield.ca or the mobile app. Sign-up for direct deposit to your bank account & follow the prompts to submit a claim.

MAIL

- Get a claim form from greenshield.ca or call 1-877-266-5494.
- Complete and mail form with original receipts to the Greenshield address listed on the form.

PROVIDER

- Ask your pharmacist and health care providers if they can submit your claim directly to Greenshield. Provide them with your Greenshield member #.
